### For illustrative purposes only

For a family of 4, with 2 adults in the 30-44 age band, the monthly premium for the health plan only would be **\$122.18**.

### How to calculate:

2 adults (using the couple rate) are  $2 \times \$40.44 = \mathbf{\$76.56}$

2 dependent children are  $2 \times \$25.68 = \mathbf{\$45.62}$

Total monthly premium = **\$122.18**

For a family of 4, with 2 adults in the 30-44 age band, the monthly premium for the health and dental plan would be **\$198.64**.

### How to calculate:

2 adults (using the couple rate) are  $2 \times \$64.75 = \mathbf{\$122.58}$

2 dependent children are  $2 \times \$42.80 = \mathbf{\$76.06}$

Total monthly premium = **\$198.64**
