How to calculate:

2 adults (using the Couple rate) are 2 x \$35.12 = \$70.24 2 dependent children are 2 x \$20.93 = \$41.86 Total monthly premium = \$112.10

How to calculate:

2 adults (using the Couple rate) are 2 x \$56.23 = \$112.46 2 dependent children are 2 x \$34.89 = \$69.78 Total monthly premium = \$182.24
